

## ATLANTIS™ WebOrder—Terms of service

Welcome to the ATLANTIS WebOrder Service (the "Service"). Your use of the Service is subject to these terms of service, which is a legal agreement between you and DENTSPLY IH AB, a company incorporated under the laws of Sweden under Reg. No. 556051-8812 ("DENTSPLY Implants"), for the use of the Service. Please read the terms of service carefully before you start to use the Service. By checking of the "I accept the terms of service" checkbox, or by using the Service, you agree to be bound by these terms and conditions, and any other terms and conditions that are incorporated herein by reference. If you do not agree with these terms of service, do not check the terms of service checkbox and do not use the Service.

### 1. DESCRIPTION OF SERVICE

The Service provides you as a customer with the ability to place orders to DENTSPLY Implants online. Information is handled by a secure connection between your computer and the DENTSPLY Implants server.

Unless explicitly stated otherwise, any new features that augment or enhance the current Service, including the release of new tools and resources, shall be subject to these terms of service. In order to use the Service, you must obtain access to the Internet, either directly or through devices that access web-based content, and pay any service fees associated with such access. In addition, you must provide all equipment necessary to make such connection to the Internet, including a computer and modem or other access device. You also understand and agree that the Service may include certain communications from DENTSPLY Implants (e.g. service announcements, administrative messages) and that these communications are considered part of the Service. If any provision of these terms of service is held by a court or other tribunal of competent jurisdiction to be invalid, illegal or unenforceable for any reason, such provision shall be eliminated or limited to the minimum extent such that the remaining provisions of the terms of service will continue in full force and effect.

## ATLANTIS™ WebOrder—Privacy policy

DENTSPLY Implants takes your privacy seriously and is committed to protecting your privacy online.
